'Most law & order issues because of them'

New Delhi: Congress president Mallikarjun Kharge on Friday said the RSS should be banned as most law and order problems in the country are arising because of BJP-RSS.

He also said Prime Minister Narendra Modi has insulted the legacy of Sardar Vallabhbhai Patel by allowing government employees to be associated with

the RSS. PM Modi had attacked the Congress on Sardar Patel's 150th birth anniversary on Friday, saying the party did not follow the tall Congress leader's vision of uniting India. Kharge hitback at the PM citing Patel's remarks criticising the RSS following the assassination of Mahatma Gandhi in 1948.

Delhi about the government lifting the ban on government employees associating with the RSS, Kharge said, "Naturally he (PM Modi) is disrespecting our Vallabhbhai Patel ji, who himself gave all the reasons why he banned the RSS and there is no ambiguity". On whether he supported a ban on the RSS, Kharge said, "It is my personal opinion

and I will say it openly, it should be done" as most of the issues and law and order problems in the country are because of the BJP-RSS. The Congress chief, who is also the LoP in the Rajya Sabha, said Patel wanted to bring in unity and peace and he fought for it. "Patel had banned the RSS in the aftermath of Mahatma Gandhi's assassination," said Kharge. **ENS**

A COURT in Andhra Pradesh's Chittoor district has sentenced five people to death for the 2015 murder of the then mayor, Katarina Anuradha, and her husband, Mohan. The Chittoor District and Sessions Judge N. Suresha Rao awarded the death sentence to Mohan's nephews, Sriram Chandra Sekhar alias Chintu, and four associates—Venkatachalapathi, Jaya Prakash Reddy, Manjunath and Venkatesh—days after they were found guilty.

Anuradha and Mohan were shot dead inside the mayor's chamber at the Chittoor Municipal Corporation of November 17, 2015. The killing was allegedly orchestrated by Chintu, who was up for being sidelined. Mohan was then vice-president of the TDP's Chittoor district unit. Investigators said gang armed with guns and daggers barged into the chamber and shot Anuradha, before chasing and stabbing Mohan to death nearby. The Chittoor Police initially named 23 people in the case. One died during the trial and another was acquitted. Of the rest, five were convicted for murder, while 16 accused of abetment were acquitted. Three accused were brought to court on Friday under heavy security.

In 2014, after the Telugu Desam Party came to power in the newly divided Andhra Pradesh, Anuradha became the first woman mayor of Chittoor.

Police found that Chintu, a marine engineer, felt slighted after being sidelined despite helping Anuradha's campaign. The probe revealed a power struggle and financial disputes between the couple and Chintu, who wanted his uncle to promote him politically. After completing marine engineering from Mumbai in 1994, Chintu joined the merchant navy and later worked for a UAE-based shipping firm. He returned to Chittoor in 2002, as Mohan rose through the TDP ranks.

Modi fuelling regional hatred during Bihar campaign: Stalin

Chennai: Tamil Nadu Chief Minister M K Stalin on Friday targeted Prime Minister Narendra Modi, accusing him of stoking regional tensions during the Bihar election campaign and "forgetting the dignity" of his office. Posting a video clip of Modi's speech from a rally in Bihar, Stalin on Thursday said,
