

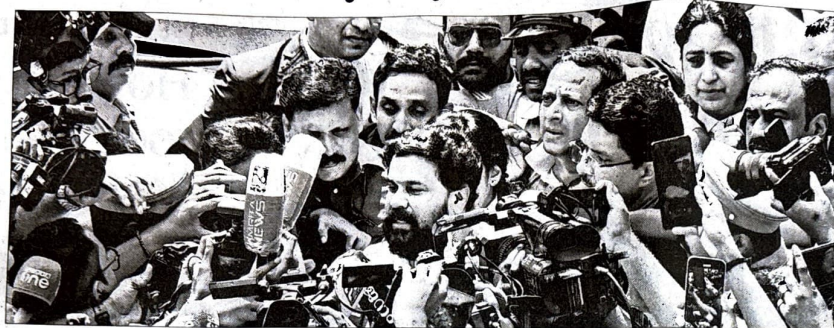
Mimicry artiste Gopalakrishnan became Dileep, Film star Dileep acquitted in 2017 actor assault case

ONCE ONE of Malayalam cinema's most bankable stars, since 2017, Dileep's career has largely been eclipsed by the abduction and sexual assault case, in which he was accused of being a conspirator and acquitted on Monday.

The 57-year-old was the 8th accused in the case. The prosecution alleged that he hired the first accused, Pulsur Sunil, to abduct the victim, a popular Malayalam film actress, sexually assault her and record the crime. It had been dubbed a rare case of 'supari' for rape.

Coming out of the court on Monday, Dileep's first reaction was to hit out against those he claimed had conspired against him — police and the media.

His first hit movie, Sallapam (1996), was a turning

Acquittal could pave way for return to film bodies that once shunned him

THE DISTRICT sessions court in Ernakulam on Monday acquitted Malayalam film actor Dileep in the 2017 case related to the abduction and sexual assault of another actor in a moving vehicle. Dileep, whose real name is Gopalakrishnan, was the eighth accused in the case. Judge Honey Varghese found the first six accused persons guilty, and the quantum of punishment will be pronounced on December 12.

Those found guilty include Pulsur Sunil, 37, a history-sheeter who allegedly had close links to the film industry. Sunil and the other five who were convicted were all said to be in the moving vehicle while the actor was being assaulted. They are Martin Antony, 33, a

there had been a conspiracy against him. Referring to another popular actor and his ex-wife, Manju Warrier, Dileep said, "It was after Manju's statement that there was a criminal conspiracy in the (actor's) sexual assault case that a conspiracy began against me. A prominent police officer and a gang of criminal police have created this. This police gang fabricated a story with the help

On Monday, apart from Dileep, the court also acquitted Charlie Thomas, Sanil Kumar alias Mestri Sanil, and Sarath Nair. Charlie had been accused of providing a hideout for other accused after the incident. Sanil had faced charges of conspiring with Pulsur Sunil in jail to extract money by threatening Dileep. Sarath faced charges for handing over and destroying the visuals of the sexual assault. The court had declared three other accused, Vishnu, Vipinlal and Aneesh, as approvers.

The state government said it would appeal the verdict and reiterated its support for the survivor, who has worked in the Malayalam, Tamil, and Telugu film industries.

SC issues notice on plea challenging election of Karnataka CM over 'freebies'

New Delhi: The Supreme Court Monday issued notice on an appeal challenging the election of Karnataka Chief Minister Siddaramaiah, which alleges that the "five guarantees" promises in the Congress's manifesto were corrupt practices under The Representation of the People Act, 1950.

The election petition against Siddaramaiah was filed by K Shankara, a voter in the Varuna constituency of Karnataka, who argued that the election results should be declared void on account of corrupt

practices under the Act.

On Monday, a bench of Justices Vikram Nath and Sandeep Mehta issued the notice after it was informed that petitions challenging the 2013 SC judgement in the Subramanian Balaji case, which said the "state distributing largesse in the form of distribution of colour TVs, laptops, etc. to eligible and deserving persons is directly related to the directive principles of the State policy", and warrants no interference by the court, are already pending for consideration by a three-judge bench.

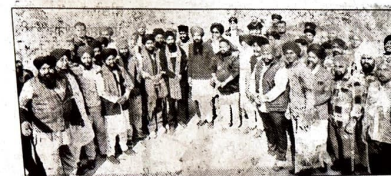
