

UNDER HIMACHAL HEALTH CARE SCHEME Man pays over Rs 2.70L for cardiac treatment: HP HC directs govt to release medical funds

THE HIMACHAL Pradesh High Court, Monday, directed the state to release medical reimbursement to a HMCARE beneficiary, after noting that the petitioner had paid over Rs 2.70 lakh despite being entitled to cashless treatment. The petitioner from Una, Surender Kumar (77), had to pay the medical expenses for his cardiac treatment at PIGMER, Chandigarh.

Hearing the writ petition by Surender, the single Bench of Justice Jyotsna Rewal Dua took serious note of the state's admission that the reimbursement claim was admissible but had not been paid.

The court directed the state government to make all possible efforts to release the amount due to the petitioner before the next date of hearing on July 7.

The petitioner is a registered beneficiary under the Himachal Pradesh government's HMCARE (Himachal Health Care Scheme), which provides cashless medical treatment to eligible residents at all the empanelled hospitals.

In 2023, Surinder developed severe heart problems and a local government hospital in Una referred him to the PIGMER.

The petitioner reported to the HC that during the treatment he received five coronary stents, including two stents in the first surgery and three in the second surgery.

Petitioner's advocate Ashok K Verma said, "The first phase of treatment, from November 28 to November 29, 2023, involved an expenditure of Rs 1,12,802; the second hospitalisation, from December 28 to

December 30, 2023, cost Rs 1,57,802. Altogether, the petitioner incurred medical expenses amounting to Rs 2,70,604."

Deputy Advocate General Menka Raj Chauhan appeared on behalf of the state.

The petition contended that despite holding a valid HMCARE card and being eligible for cashless treatment, the petitioner was compelled to arrange the entire amount because the state failed to honour its obligations under the scheme. The money had to be arranged with great difficulty owing to the medical emergency, the petition said.

During the hearing, the petitioner's counsel referred to a legal notice served on December 12, 2025, to the Chief Executive Officer (CEO) of the HP Swasthya Bima Yojna Society, seeking reimbursement of the amount spent.

In its reply dated February 2, 2026, the CEO acknowledged that reimbursement of both claims was admissible.

However, the authority informed the petitioner that payment could not be released due to lack of funds under the HMCARE scheme, the petitioner's counsel said.

Taking note of this stand, the HC observed, "Evidently, the amount has not been released to the petitioner on the stated non-availability of funds under the HMCARE Scheme. Prima facie, in view of the state's commitment under the HMCARE Scheme and the liability towards the petitioner admitted by it, learned Deputy Advocate General (is directed) to have instructions in the matter. Efforts be made to release the amount due to the petitioner by the next date of hearing."

Shooting stone crushes car, kills teen; bus overturns in Mandi

Orange alert issued for Shimla, Kangra, Solan and Mandi as IMD warns of more heavy rain, landslides and flash floods

A 14-YEAR-OLD girl was killed and 17 others were injured in separate rain-related accidents across Himachal Pradesh on Monday, as incessant rainfall continued to trigger dangerous conditions across the state.

In Chamba district, Dikshita (14) died after a massive boulder crashed onto the car she was travelling in on the Dhakog-Banni Mata Temple road in Bharmour subdivision. Four others were injured in the incident.

According to police, two families from Dharamshala's Naddi area had travelled in two vehicles to offer prayers at the Banni Mata Temple. While returning, a huge boulder rolled down the hillside near Aura Kainchi bend and smashed through the roof of one of the vehicles.

In a separate incident in

Mandi district, 13 passengers were injured after a private bus overturned near Bhawana on the Bilaspur-Mandi highway in Sundernagar subdivision. The accident occurred when a portion of the rain-soaked road reportedly caved in around 200 metres before Bhawana bridge, causing the bus to lose balance and overturn.

The bus, carrying 42 passengers from Bilaspur to Sundernagar, overturned on its side, trapping several passengers inside. They were rescued by locals and emergency responders before being shifted to hospital. Police said some of the injured sustained serious injuries.

Local MLA Rakesh Jamwal and senior administrative officials visited the injured at the hospital.

The district administration directed hospital authorities to ensure prompt treatment and assured all possible assistance

to the victims.

Meanwhile, in Shimla, four parked vehicles were damaged after a dry pine tree collapsed on Chamyana Road during rainfall. No injuries were reported.

Traffic police and officials cleared the fallen tree and restored traffic. Authorities have advised motorists against parking near weakened roadside trees during adverse weather.

The India Meteorological Department (IMD) has issued an orange alert for Shimla, Kangra, Solan and Mandi districts for Tuesday, warning of heavy to very heavy rainfall at isolated places. A yellow alert has been issued for Bilaspur and Sirmaur.

During the past 24 hours, Jogindarnagar in Mandi recorded the highest rainfall at 10 cm, followed by Kangra Airport (7 cm), Sandhole (5 cm) and

Congress prepares for 2027 HP assembly polls, focuses on strengthening grassroots outreach

CONGRESS ON Monday said it has begun preparations for next year's assembly elections, announcing a series of organisational measures, including assigning ministers and office-bearers district-wise responsibilities, and taking strict action against indiscipline.

Addressing reporters, Congress in-charge for Himachal Pradesh, Rajani Patil, said that

all ministers and district, block presidents would be assigned one district each to strengthen the party at the grassroots level and improve coordination among workers.

Patil said that a "connect centre" has been established at the state headquarters, Rajiv Bhavan, to monitor organisational activities and party programs at the district and block levels. "Congress ministers in the state will be given charge of one district each so that they

can make the organisation's functioning effective by directly communicating with the party workers in those districts," she said while addressing reporters.

She warned that the work of all district and block officials would be reviewed every three months and those failing to carry out their organisational responsibilities would be "relieved of their positions".

The Congress leader said that a meeting of the Political

Affairs Committee (PAC) will be held in Dharamsala soon, and All India Congress Committee Organisation General Secretary K C Benugopal will be the key-note speaker.

Speaking about the Ram temple donation theft row, Patil said that the Congress party will effectively communicate to the people about the alleged "theft and looting" of Ram Temple donations, saying that "plunder in the name of faith cannot be tolerated".

Helitaxi services begin between Mandi, Kullu and Chandigarh

HIMACHAL PRADESH Chief Minister Sukhvinder Singh Sukhu virtually inaugurated the helitaxi services daily between Mandi- Chandigarh and Kullu- Mandi- Chandigarh, on Monday.

A spokesperson said, "The Mandi- Chandigarh helicopter service would be operated under the GoI's Regional Connectivity Scheme (RCS-UDAN), while the Kullu- Mandi- Chandigarh sector would be operated by Heritage Aviation Pvt Ltd on a Non-RCS (market-based) model. The service from Kullu would operate at 9 am and reach Mandi at 9:10 am; it would depart from Mandi at 9:15 am and arrive in Chandigarh at 9:45 am. From Chandigarh, the helicopter would fly at 10 am and reach Mandi at 10:30 am, and from Mandi it would undertake a sortie at 10:35 am and arrive at Kullu at 10:45 am."

The services would operate from the Kangnidhar (Mandi) Helipoint. Under the RCS-UDAN Scheme, the indicative airfare for the Mandi- Chandigarh sector is Rs 3,500. The fare for the Kullu- Mandi- Chandigarh sector is Rs 8,500.

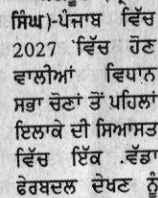

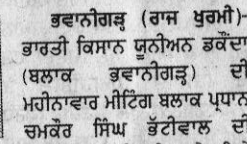
