

Physical fitness key to China triumph, say Satwik-Chirag

NEW DELHI, SEPTEMBER 7
Satwiksairaj Rankireddy and Chirag Shetty do not believe in a Plan B. Instead, the Indian badminton stars prefer to stick to their strengths while making the necessary adjustments to counter different opponents, a formula that helped them conquer the China Masters.

The world No. 5 pair, who had finished runners-up at the 2023 and 2025 editions, stressed the importance of sticking to their strengths while adapting their tactics according to their opponents. "It's always Plan A, there is no Plan B for us. But I think it depends on opponents who we are playing. It's never easy. It's tough," Satwik said on Monday during a virtual interaction facilitated by Badminton Association of India (BAI).

Elaborating on their tactical approach, he added, "If you're playing with some Indonesians, Malaysians who are not really strong hitters, we want to open up and play some defense game, then try to get into the attack."

"But if we are playing with someone who has good attack, we want to take a chance in the frontcourt and challenge them and see and take from there," Both Satwik and Chirag attrib-

uted their historic recent triumph to a marked improvement in their physical condition, following a disappointing outing at the BWF World Championships where they had limited court time and struggled with match sharpness.

"I think it's mainly physical. I think, I think physical really. I think we became much better after World Championship. We got a time, we got adjusted," Satwik explained.

"Then, we weren't sure as well in China Masters, like how much we can cope up with the body throughout the week. So we are just taking one match at a time. So I think overall, it was pretty much comfortable throughout the week. So that's a good sign going ahead."

Reflecting on the takeaways from the World Championships, Satwik noted that realising they could compete at a high level even when not at 100% physical capacity provided a massive psychological boost. "Even without our A weapons, we kind of playing at a high level. So that was a very good point, as in like physically wasn't there, like fully not yet there. But I think still playing at the top level. I think that was a huge confidence for us," he said. — PTI

US OPEN

Defending champions Aryna Sabalenka and Carlos Alcaraz are back to the quarterfinals at the US Open. The top-ranked Sabalenka solved some

early struggles holding serve and overpowered Taylor Townsend 6-4 6-3 on Sunday. Alcaraz also advanced in straight sets, beating Tommy Paul 6-4 6-3 6-4 in the second match at Arthur Ashe Stadium.

Alcaraz returns in style

Playing his first tournament following a four-month absence because of a right wrist injury, Alcaraz said last week he would not be coming back if he could not play like his usual self. The 23-year-old Spaniard has made good on

that so far, dropping just one set through four rounds.

Aryna gathers pace

Top seed Aryna Sabalenka earlier broke down the defences of 96th-ranked American Taylor Townsend to win 6-4 6-3 in a competitive

contest that belied the gulf in their rankings, subduing the inventive left-hander with a largely pristine display. Next up for Sabalenka is Wimbledon winner Linda Noskova, who needed six match points to get past Marta Kostyuk 7-5 7-6-4.

There will also be an all-American matchup in the women's quarterfinals. No. 3 Jessica Pegula got there by beating No. 16 Sorana Cirstea and will face 26th-seeded Emma Navarro, who ousted No. 21 Annia Kalinskaya in straight sets. — PTI
